

ORDINANCE NO. 006-2014


A SPECIAL ORDINANCE AMENDING CHAPTER 16, ARTICLE III,
SECTIONS 16-85.1 AND 16-85.2, OF THE CODE OF ORDINANCES
OF THE CITY OF ROCK ISLAND, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCK ISLAND, ILLINOIS:

Section One. That Chapter 16, Article III, is hereby amended by deleting Sections 16-85.1 and 16-85.2 in their entirety and by inserting in lieu thereof the attached Exhibit A which is made a part hereof by reference.

Section Two. All ordinances and parts of ordinances in conflict herewith are hereby repealed insofar as they do so conflict.


Section Three. This ordinance shall be in full force and effect from and after its passage and approval, as required by law.

Sec. 16-85.2. *Three-Part Rate:* A three-part rate may be levied to those users whose wastewater varies significantly from normal domestic concentrations for BOD and SS. The three-part rate would consist of a service charge plus a unit charge for volume, biochemical oxygen demand (BOD), and total suspended solids (TSS).

Service charges for customers paying based upon the three-part rate will be calculated by the public works department on a case by case basis.

The concentration of wastes used for computing BOD and TSS charges shall be established by waste sampling. Waste sampling shall be performed as often as may be deemed necessary by the City and shall be binding as a basis for the BOD and TSS charges. In the event a customer requests to be placed on a three-part rate schedule, the cost of performing the necessary waste sampling shall be charged directly to the customer.
