
The public hearing will be held to receive evidence concerning the disability application of the above Applicant and the Board will consider the Joint Motion to Permit Limited Intervention and Applicant's Motion to Amend his Disability Application. The Applicant is entitled to be represented by legal counsel, to present any evidence and to respond to any evidence before the Board.

The public hearing is being held via videoconference without the requirement of in-person attendance in accordance with Governor Pritzker's Executive Order. Public comment will be held during the meeting and will be limited to 5 minutes per person.

The Pension Board may adjourn to Executive or Closed Session, pursuant to §2(c)(4) of the Open Meetings Act, for purposes of deliberations, upon completion of the evidentiary hearing. No final action will be taken in Executive/Closed Session.




