Focus Group - Homelessness

Key Information and Findings: Homelessness continues to be a concern across the Quad Cities region. In Rock Island, Christian Care houses the men and women's shelters, however they do require sobriety, which can be a barrier to some. Humility Homes in Davenport, Iowa provides the only regional low-barrier shelter as well as the only winter shelter. Illinois-side agencies assist with transportation to the Iowa side during the cold winter months to access the shelter.

Participants discussed various barriers in addressing homelessness including: "red tape" with access to funding (i.e.: does not cover operating costs and requires rigorous reporting); lack of affordable housing options; limited shelter space; need for showers and lockers; more collaboration with federal and state governments; need for preventive funding; need to address the gap in eviction diversion; and better communication and collaboration among the various agencies that provide services, including a pocket-sized list of resources.

Focus Group – Mental Health

Key Information and Findings: Access and availability to mental health resources continues to be a challenge in the Quad Cities region. Specifically, the decline in the number of mental health professionals and services coupled with an increase in the need has made it very difficult for many to access resources.

Participants discussed gaps and barriers including: a broken system with lots of layers and programs that make access to mental health difficult to navigate; many are leaving the mental health field for several reasons, including low pay and the need to pay off student loan debt; the mental health system is currently reactive and needs to be preventative; there is a need for a more collective approach with schools, families, and other agencies; no readily accessible resource list; there are not many options with getting an individual with immediate need care after 5:00 p.m. other than the emergency room; need for a partnership with police department; lack of crisis and trauma training in the community; and the need for more beds at mental health facilities.

Focus Group - Tourism

Key Information and Findings: Tourism is a regional approach and visitor information is tracked by Visit Quad Cities through Datafy, a geo-location data analytics and marketing software program. Focus Group participants suggested the continuation and growth of a staple event(s) or attraction(s) that draws people to Rock Island such as Ya Maka My Weekend; package several Rock Island attractions together; tell a story about the uniqueness of Rock Island (e.g. John Looney, history of NFL, rivers, industry); hire a part-time person for peak tourism hours and days that can assist with packaging and marketing attractions specifically for Rock Island, among other things; provide a studio and/or art venue similar to what Bucktown was in Davenport; and create a Tourism Task Force.

Focus Group – Tourism

Recommendation: Based on feedback from the Tourism Stakeholder Focus Group, it is recommended that the City explore the feasibility of establishing a Destination Management and Marketing Organization (DMMO) through the RFP process.

The pipe had a previous failure that allowed all of the water from the slough to inundate the pipe and create sewer backups into different facilities at Augustana College. In order to prevent future failures and liability, the pipe needs to be replaced as soon as possible.• Infrastructure (water and sewer) scored the highest among stakeholders who completed the survey.• Project meets Council goal of Financial Sustainability. Non-Profit Information

- **In September 2022, 4 nonprofits were discussed for potential ARPA funding. City Council directed the ARPA Program Manager to provide additional information and data on the 4 nonprofits:**
 - *Botanical Center*
 - *Backwater Gamblers*
 - *MLK Fun Day*
 - *QC Arts*

Non-Profit Information – Botanical Center

Proposed Funding amount: \$150,000 (*funds would be used to pay off \$91,000 mortgage and remaining funds would be invested into exhibits*)

- **50,000-60,000 (3-year range excluding 2020) on-site visitors, tourists, learners or private party guests annually.**
- **8,000-10,000 school aged children on-site for formal programming through school district.**
- **Scholarships for Rock Island/Milan School youth for Title 1 schools.**



Non-Profit Information – Backwater Gamblers

Proposed Funding amount: \$100,000 (funds would be used towards partially funding two projects: update two boats and site improvements including a new dock, boat storage unit and bleachers)

- **Estimated annual economic impact: \$900,000. Potential for greater economic impact of hosting national and regional tournaments.**
- **Free Water Ski Shows – there is no charge for admission.**
- **Attract approximately 30,000 to 35,000 visitors annually.**



Non-Profit Information –MLK, Jr. Center

Proposed Funding amount: \$90,000 (\$40,000 would be used for MLK Day and an additional \$50,000 is needed for the West End Renaissance Project for a total of \$90,000)

- The MLK Center has proudly served as a community anchor in Rock Island since 1975. It is located and focused in an area that is 57% black, facing exceedingly high poverty rates.
- The MLK Center serves 20,000 people annually, including over 2,300 youth
- The King Center provides various services including after school youth programs, healthcare clinics, Thanksgiving meals, computer classes, among other services.



Non-Profit Information –Quad City Arts

Proposed Funding amount: \$50,000 (Funds could be used towards a new Rock Island event, materials and artist fees, or a maintenance plan for public art such as murals)

- **Gallery and retail space in Rock Island - sees an average of 5,000 visitors annually.**
- **Metro Arts Youth Apprenticeship Program – Projects in the City of Rock Island vary based on funding, but every year the program includes students from Rock Island. In 2022, we had 14 students in the program, all of which were paid.**
- **According to the Americans for the Arts Economic Prosperity Calculator, Quad City Arts has an economic impact of \$4.4 Million.**



Housing Rehabilitation

\$250,000 allocated ARPA funds for Housing Rehabilitation will be incorporated into the existing owner-occupied housing for LMI households



Demolitions

\$250,000 allocated ARPA funds for Demolitions will be incorporated into the existing demolition process.
