Background

- DARI was formed in 1974 to bring industrial, recreational, workforce, and other Growth to Rock Island.
- DARI and the City have worked together over the years to create opportunities for development within the City of Rock Island.
- City staff was asked to explore additional partnership opportunities between the City of Rock Island and DARI.

2020-2022 Proposal

- The City of Rock Island and DARI will work in partnership to increase efforts in the following areas:
 - Retail/Commercial Business Attraction
 - Business Retention & Expansion
 - Support and Engagement of Local Businesses
 - Marketing

2020-2022 Proposal

- DARI has proposed the development of four new committees to assist in this effort:
 - **Business Development** – Serve as community liaisons to new and established businesses looking to locate, start, or grow in Rock Island.
 - **Real Estate Development** – A coalition of area real estate and construction professionals that guide development projects to take shape in Rock Island.

2020-2022 Proposal

- **Economic Development** – Lead corporate stakeholders that seek to improve the economic well-being and quality of life for Rock Island by creating and/or retaining jobs and supporting or growing incomes and the tax base.
- **Marketing & Events** – Small business owners that desire to produce special events and promote Rock island.
