#### **IGC Number 20-024**

**Case I:** Case and complaint number 20-024 El Patron in the District d/b/a El Patron Restaurant and Bar called for hearing on alleged violation of code section 15-114 of the Code of Ordinances of The City of Rock Island, Illinois, entitled "Enforcement License Suspension, Revocation. Authorized representative for El Patron, Consuelo Gonzalez, appears. Evidence taken and commission found respondent did not pay its food and beverage tax in a timely manner as required by the City of Rock Island's Code of Ordinance in a timely fashion. Fine of \$200 imposed.

#### **Case II:**

Case number 20-024 El Patron in the District, Inc. d/b/a Galleries in the District

called for hearing and disposition on alleged violation of code section 15-114 of the Code of Ordinances of The City of Rock Island, Illinois, entitled "Enforcement License Suspension, Revocation" delinquent food and liquor sales tax. Authorized representative for El Patron, Consuelo Gonzalez, appears. Evidence taken and commission found respondent did not pay its food and beverage tax for the months of December 2019 through July 2020, as required by the City of Rock Island's Code of Ordinance in a timely fashion. Fine of \$200 imposed.

**Case III** PSR Petro Mart d/b/a Jesse Mart called for hearing and disposition on alleged violation of code section 15-114 of the Code of Ordinances of The City of Rock Island, Illinois, entitled "Enforcement License Suspension, Revocation" delinquent food and liquor sales tax. Attorney Robert Noe appeared with Respondent. Stipulation of violation entered into. Respondent admits violation and a fine imposed.

**Case IV:** Guru Nanak Petro Mart Inc. d/b/a Save More called for hearing and disposition on alleged violation of code section 15-114 of the Code of Ordinances of The City of Rock Island, Illinois, entitled "Enforcement License Suspension, Revocation" delinquent food and liquor sales tax. Respondent stipulates to violation and warning issued to Respondent.

**IGC No. 20-016:**

1. Born Entertainment, L.L.C. d/b/a Smoking Dog called for hearing on to alleged violations Count I Minor on Premises in violation of Chapter 3 Section 3-10, paragraph (i) and Count II Sale to Minor Prohibited in violation of Chapter 3, Section 3-10, paragraph (b). The Respondent stipulated to the violations and a warning letter was issued.

**IGC No. 20-017**

Billy Bob's Quad Cities, LLC d/b/a Billy Bob's Quad Cities LLC called on for hearing on allegation of Minor on Premises in violation of Chapter 3 Section 3-10, paragraph (i). Respondent appeared and stipulated to violation and a warning letter was issued.

**IGC No. 20-018**

Liquor Corner, LLC d/b/a Riverside called on for hearing on allegation of Employment of a minor in violation of Chapter 3, Section 3-10, paragraph (h). Respondent appears personally. Officer sworn, testimony taken and redacted body camera footage presented. Respondent initially denied testimony of officer but then stipulated to violation during his presentation of evidence. Three (3) day suspension of liquor license and \$200 fine imposed.

**IGC No. 20-019**

PSR Petro Mart d/b/a Jesse Mart called for hearing and disposition on alleged violation of Chapter 3, Section 3-11, paragraph (p) entitled "Loitering/Disorderly Conduct" in violation of the Code of Ordinances of The City and also Violation of code section 15-114 of the Code of Ordinances of The City of Rock Island, Illinois, entitled "Enforcement License Suspension, Revocation" delinquent food and liquor sales tax Licensee, PSR Petro Mart d/b/a Jesse Mart, appears personally and by its Attorney Robert Noe. Respondent stipulates to violation and imposition of 48 hour suspension of license and Imposition of \$500 fine.


**IGC No. 20-020**

Spartan's Pub, LLC, d/b/a The Black Sheep called on for hearing on allegation of violation of Chapter 3, Section 3-11, paragraph (p) entitled "Loitering/Disorderly Conduct". Respondent stipulates to violation and one day suspension of liquor license.

**IGC No. 20-023**

Endeavor, LLC d/b/a Brandon's Pub and Grille called on for hearing on allegations violation of Chapter 3, Section 3-10, paragraph (b) entitled "Sale to Minor prohibited" and Chapter 3, Section 3-10, paragraph (i) entitled "Minor on Premises Prohibited in violation of the Code of Ordinances of The City of Rock Island. Respondent stipulated to the violations and a warning letter was issued.

Motion to adjourn made and seconded. Meeting adjourned by acclamation.
