Attached is an application, letter and two (2) route maps from Crystal Bowen, Director of Community Relations for the Quad Cities River Bandits. They are requesting permission to hold a 5K Run/Walk on Saturday, April 8, 2017 from 9:00 am to 10:00 am. The race will begin and end at Modern Woodmen Park in Davenport, Iowa.

Also attached is a Resolution to be adopted by the City Council for temporary closure of Highway 67 (Centennial Bridge) to 2nd Avenue and Highway 92 from 16 ½ Street to 18th Street.

The Quad Cities River Bandits will be working with the Police Department for traffic control. It is noted that the Quad Cities River Bandits has notified and received permission from the Rock Island Parks and Recreation Department for utilization of the bike paths.

The purpose of this race is for a fundraiser for the Quad City River Bandits Scholarship Program (Bandit Scholars) for Quad City area college students. The certificate of insurance is attached.

The Quad Cities River Bandits request approval from the City of Rock Island to conduct a 5K race on the morning of April 8, 2017. The race will begin on 2nd Street and end at Modern Woodmen Park, where there will be awards, refreshments, food, games, activities for kids, vendor booths, music and more. The course will cross over the Mississippi River to include both the Iowa and Illinois sides of the Quad Cities. We have researched the date and are confident we are not imposing on any other race in the immediate area. The race will begin at 9:00am on 2nd Street, between Western Ave and Gaines St, and will conclude inside the ballpark.

Our formal request is as follows:

- Closure of 2nd Street in Davenport from Western Avenue to the Centennial Bridge from 8:30 to 9:15am
- Reduced northbound lane of Centennial Bridge from 8:30 to 9:30am.
- Reduced lane on 2nd Avenue in Rock Island between Centennial Bridge and 17th Street from 8:30am to 10:00am.
- Closure of 17th Street (connecting the runners from 2nd Avenue to bike path) from 8:30 to 10:00am.
- Permission to use bike path between Centennial Bridge and 24th St in Rock Island (bridge leading to Arsenal Island) from 8:30 to 10:00am.
- Closure of bike path from Arsenal Bridge to modern Woodmen Park from 9:00 to 10:00am.

The QC River Bandits believe this will be a fun event for families and residents of the QC area and are looking forward to continuing the annual Race to Home 5K at Modern Woodmen Park. The approval of this request and the assistance of the City departments (where needed) will be deeply appreciated.



RESOLUTION NO. 01-2017

HIGHWAY RESOLUTION

WHEREAS, the **QC River Bandits** is sponsoring a **5K Run/Walk** in the CITY of ROCK ISLAND which event constitutes a public purpose;

WHEREAS, this **Race** will require the temporary closure of the **Eastern most Northbound lane on Highway 67 (Centennial Bridge) to 2nd Avenue, AND Highway 92 from 16 ½ Street to 18th Street**, a State Highway in the CITY of ROCK ISLAND.

WHEREAS, Section 4-408 of the Illinois Highway Code authorizes the Department of Transportation to issue permits to local authorities to temporarily close portions of State Highways for such public purposes;

NOW THEREFORE, BE IT RESOLVED by the CITY COUNCIL of the CITY of ROCK ISLAND that permission to close off the **Eastern most Northbound lane on Highway 67 (Centennial Bridge) to 2nd Avenue, AND Highway 92 from 16 ½ Street to 18th Street**, as above designated, be requested of the Department of Transportation.

BE IT FURTHER RESOLVED that this closure shall occur during the approximate time period between **8:30 A.M. and 10:00 A.M. on Saturday, April 8, 2017.**

BE IT FURTHER RESOLVED that this closure is for the public purpose of use for the **Quad Cities River Bandits 5K Race.**

BE IT FURTHER RESOLVED that traffic from that closed portion of highway shall be detoured over routes with an all-weather surface that can accept the anticipated traffic, which will be maintained to the satisfaction of the Department and which is conspicuously marked for the benefit of traffic diverted from the State Highway. (The parking of vehicles shall be prohibited on the detour routes to allow an uninterrupted flow of two-way traffic.)* The detour route shall be as follows: **Detour as follows: Eastbound 92 traffic shall be directed South on 16th Street to 3rd Avenue East or West when available and onward. Westbound 92 traffic shall be directed South on 18th Street to 3rd Avenue West and onward.**

BE IT FURTHER RESOLVED that the **Quad Cities River Bandits** assumes full responsibility for the direction, protection, and regulation of the traffic during the time the detour is in effect.

BE IT FURTHER RESOLVED that police officers or authorized flaggers shall, at the expense of the **Quad Cities River Bandits**, be positioned at each end of the closed section and at other points (such as intersections) as may be necessary to assist in directing traffic through the detour.

BE IT FURTHER RESOLVED, that police officers, flaggers, and officials shall permit emergency vehicles in emergency situations to pass through the closed area as swiftly as is safe for all concerned.

BE IT FURTHER RESOLVED, that all debris shall be removed by the **Quad Cities River Bandits** prior to reopening the State Highway.

BE IT FURTHER RESOLVED, that such signs, flags, barricades, etc., shall be used by the **Quad Cities River Bandits** as may be approved by the Illinois Department of Transportation. These items shall be provided by the **Quad Cities River Bandits**.

BE IT FURTHER RESOLVED, that the closure and detour shall be marked according to the Illinois Manual on Uniform Traffic Control Devices.

BE IT FURTHER RESOLVED that an occasional break shall be made in the procession so that traffic may pass through. In any event adequate provisions will be made for traffic on intersecting highways pursuant to conditions noted above. (Note: this paragraph is applicable when the Resolution pertains to a parade or when no detour is required.)

BE IT FURTHER RESOLVED, that the **Quad Cities River Bandits** hereby agrees to assume all liabilities and pay all claims for any damage which shall be occasioned by the closing described above.

BE IT FURTHER RESOLVED, that the **Quad Cities River Bandits** shall provide a comprehensive general liability insurance policy or an additional insured endorsement in the amount of **\$100,000 per person and \$500,000 aggregate** which has the Illinois Department of Transportation and its officials, employees, and agents as insured and which protects them from all claims arising from the requested road closing.

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Department of Transportation to serve as a formal request for the permission sought in this Resolution and to operate as part

of the conditions of said permission.
