Dear Contractor:

Your 2025 contractor registration will expire on December 31<sup>st</sup>, 2025. In order to obtain a permit in 2026, your registration must be current. Please make sure an updated certificate of liability insurance is provided with your registration as well as an updated State of Illinois Roofing License if you plan to pull roofing permits in 2026.

Proof of workers compensation insurance or proof that you are an approved self-insurer of workers compensation must also be provided with your registration. If you will not have employees performing work during the 2026 registration period, then a written statement confirming this shall be submitted in place of workers compensation insurance.

**The City is now on the 2021 International Codes Cycle.**

**Keep the following responsibilities in mind when performing work in Rock Island:**

- City code requires that permits must be pulled **before** work is performed and that a permit must be retained on the job site.
- It is the contractors' responsibility to keep their insurance and bond current. If insurance and bond information is not current, your registration will not be processed.
- **Every permit issued requires an inspection.** City code requires that inspections are conducted during applicable stages in the build and that a final inspection or occupancy inspection is conducted in order to close the permit.
- Proposed changes must be submitted and approved by the Building Official before modifications are initiated.
- **ALL INSPECTIONS REQUIRE A MINIMUM OF 24-HOUR NOTICE**

I am aware that workers' compensation insurance must be provided if employees will be performing work during this registration period. If workers' compensation insurance is not provided, a written statement must be submitted in its place.

Under penalties of perjury, the undersigned certifies that all information in this statement, and all information furnished in support of the statement is true and complete to the best of his/her knowledge and belief. Failure to comply with the conditions of this registration will result in revocation of the registration and cancellation of all active permits.
