

- 2) East on 3rd Ave to 23rd Street
- 3) South on 23rd St to 4th Ave
- 4) West on 4th Ave to 7th Street & 3rd Ave (IL 92 overpass)
- 5) 3rd Ave continuing on to Mill St
- 6) South on Mill Street to 18th Ave
- 7) West on 18th Ave to Sunset Lane
- 8) South on Sunset Lane Through Sunset Park
- 9) Turnaround on Sunset Lane
- 10) North on Sunset Lane to 18th Ave
- 11) East on 18th Ave to Mill Street
- 12) North on Mill Street to 3rd Ave
- 13) 3rd Ave continuing east on to 4th Ave
- 14) East on 4th Ave to 17th Street
- 15) North on 17th street finishing in front of 227-17th Street (Steve,s Old Time Tap)

Alternate course if Mill Street Construction is not finished will be the same course except at the construction site on Mill Street runners will detour on to bike path heading towards Sunset & in to the park returning back out of park on to Bike path & continuing on Mill street back to 4th Ave finishing on 17th Street.
