Attached is a letter from Martinis on the Rock requesting permission to hold an event outside on Sunday, September 2, 2012 from 1:00 pm to 7:00 pm at 4619 34th Street. Augustana College Greek Life will be providing live music (band) from 2:00 pm to 6:00 pm along with other activities for this event.

The event will be held on the fenced in patio. No alcohol will be sold outside. However, patrons will be allowed to carry their alcoholic beverages from inside the establishment to the fenced in area outside. Minors will not be allowed in the fenced in area. Three off duty Police Officers will be provided by Augustana College Greek Life.

Augustana College's Office of Student Activities has granted permission for the student organizations to co-host this event at Martinis on the Rock at 4619 34th Street. The letter of permission is attached.

RECOMMENDATION:

It is recommended that Council approve the outdoor event for Martinis on the Rock, subject to complying with all liquor license regulations and subject to being closed down early if noise complaints are received.


