Attached is an Activity application, Great River Plaza application, two letters and two maps from Paige Nagle of Gilda's Club Quad Cities and The District. Gilda's Club Quad Cities is requesting to hold a 1Mile and 5K Run/Walk for Saturday, April 18, 2015 from 9:00 am to 11:00 am. This event will be co-sponsored by The District. Executive Director Catherine Rodgers-Ingles of The District has reviewed and approved the Great River Plaza/District event application. For the last 10 years, this event has been held in Bettendorf, Iowa and Gilda's Club Quad Cities would like to relocate this event to Rock Island.

The 1 Mile and 5K will begin and end at 18<sup>th</sup> Street and 2<sup>nd</sup> Avenue and the 1 Mile Run will occur in the footprint of the 5K Run, which is partially outside of the Plaza-District area. A post-race celebration will be held at RIBCO immediately following the race. They are requesting that a portion of 18<sup>th</sup> Street between 1<sup>st</sup> and 3<sup>rd</sup> Avenues be closed for this event.

Due to the 5K Race being partially outside of the footprint of the District area, the new Activity Event Policy would need to be followed. A resident and business sponsor notification form was submitted with the description and details of the event. The attached notification map identifies 198 residents and/or businesses that would need to be notified. However, the route has now been modified to minimize the impact on the area and the only street to be closed is a portion of 18<sup>th</sup> Street between 1<sup>st</sup> and 3<sup>rd</sup> Avenues, which is in the Plaza-District area. It is noted that District staff has been working with Gilda's Club since October to move this race to Rock Island, and the original event application packet was scheduled to be included with the 2015 upcoming Plaza events until they were informed of the new Activity Policy that was recently approved. Also attached is a letter from Executive Director Catherine Rodgers-Ingles of The District requesting a waiver of the notification process. Since the original route was modified and the only portion of a street to be closed is in the Plaza-District area, it is being recommended to waive Chapter 8, Sec. 9-113 (2) of the Code of Ordinances regarding the notification requirement.

In addition, Gilda's Club Quad Cities is requesting a waiver of the \$35.00 permit fee. It is noted that this is a family friendly event and all proceeds from this event will benefit free social and emotional support services offered by Gilda's Club Quad Cities for those that have been affected by cancer.

Gilda's Club Quad Cities and The District have contacted the Police Department for traffic control and they will be working very closely with the Police Department to minimize the disruption of traffic flow. The certificate of insurance is attached.

**RECOMMENDATION:**

It is recommended that Council approve the event applications for Gilda's Club Quad Cities, waive the notification requirement and the permit fee.

# Gilda's Run for Laughs

## 5K & 1 Mile Fun Run

Dear Ms. Patchin,

We are requesting a permit for our annual 5K fundraiser, which we hope to hold in Rock Island on Saturday, April 18<sup>th</sup>, 2015. All proceeds from Gilda's Run for Laughs will benefit the free social and emotional support services offered by Gilda's Club Quad Cities to all those affected by cancer.

We also request that the permit fees be waived. For over 10 years, this 5K has been held in downtown Bettendorf. We are very eager about the possibility of moving this event to Rock Island and creating an exciting new life for this family-friendly event. The event will not only draw people downtown, but all funds raised will help local families touched by any type of cancer. On our behalf, please share this letter of request with the Rock Island City Council Members to consider waiving the \$35 permit fee.

As we will incorporate use of the Great River Plaza before, during and after the actual race, we have enclosed both the City of Rock Island license application and a Great River Plaza Activity Event permit applications. We are working closely with The District and Rock Island Brewing Company in order to enhance the event and provide a unique experience to our participants and guests. Immediately following the race, we intend to hold an after-race celebration at RIBCO. Cornbelt Running Club will also provide their expertise thereby ensuring a safe and successful event.

Also enclosed please find <sup>or</sup> map of the race course. Per your request, we have modified the route to reduce the manpower necessary for traffic control and minimize impact on the immediate area. We plan to close only 18<sup>th</sup> Street between 1<sup>st</sup> and 3<sup>rd</sup> Avenues to accommodate the start and finish of the race, and will work with the Rock Island Police Department to control traffic throughout the course.

Gilda's Club, in conjunction with The District, recently submitted an activity permit application in order to relocate their annual 5K fundraiser, *Gilda's Run For Laughs*, from Bettendorf to downtown Rock Island. District staff has been working with Gilda's Club in order to facilitate this move since October of last year.

Upon presenting the application, it was brought to our attention that a new ordinance had been created that requires that every business and residence be notified prior to event approval. As you are aware, this event begins and ends on the Great River Plaza, however, the race route ventures outside of the physical boundaries. While we understand the importance of informing the community of impending events and activities that may impact traffic flow, we also must ask that this requirement be waived for this event.

*Gilda's Run For Laughs*, while new to Rock Island, has operated without issue in Bettendorf for the past 10 years. It is a family friendly event, and a major fundraiser for the organization. By co-sponsoring this event, we will add an after party at Rock Island Brewing Company that will feature a Blues Brothers tribute band, thereby incorporating Rock Island's affinity for the iconic duo, and providing exposure while supporting local business.

Due to the date of the event, April 18<sup>th</sup>, the process of contacting approximately 198 individual residents and businesses to get their written approval would require an extraordinary amount of manpower, and would severely impact the success of the event. Marketing efforts and registration must begin no later than the first of March.

In addition, the route of the run is the same footprint as the Modern Woodman run that was held in September of last year. This was a one-time event. We will be working closely with the Rock Island Police Department to ensure minimum disruption of traffic flow, and will only be closing a portion of 18<sup>th</sup> Street (between 1<sup>st</sup> and 3<sup>rd</sup> Avenues) to accommodate the start and finish of the race.

We wish to be accommodating and receptive to new events and activities that will help us keep Rock Island a vibrant and creative community. Therefore, we respectfully request that this requirement be waived for this event. Thank you for your consideration.

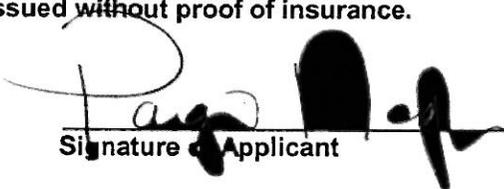

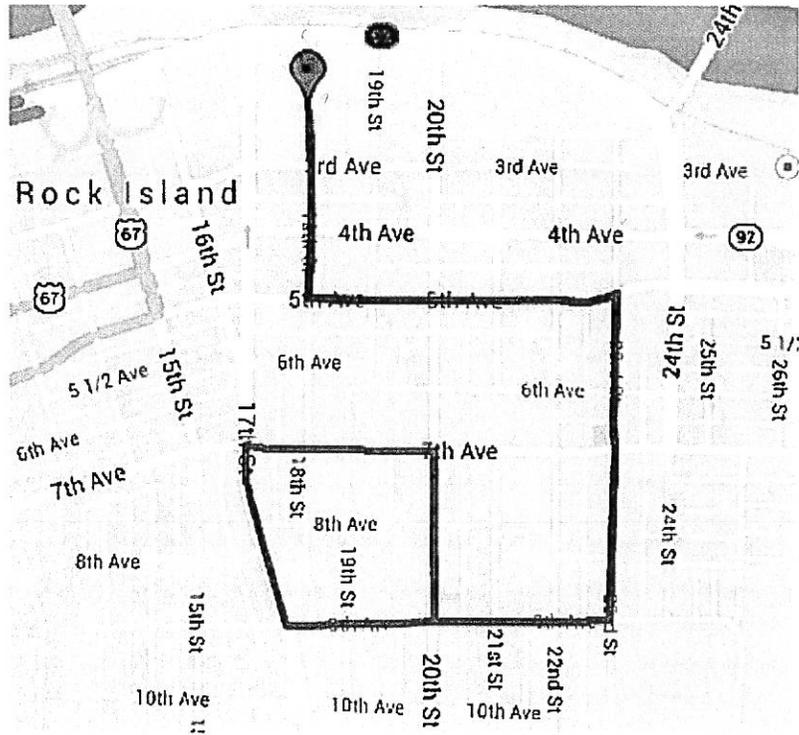

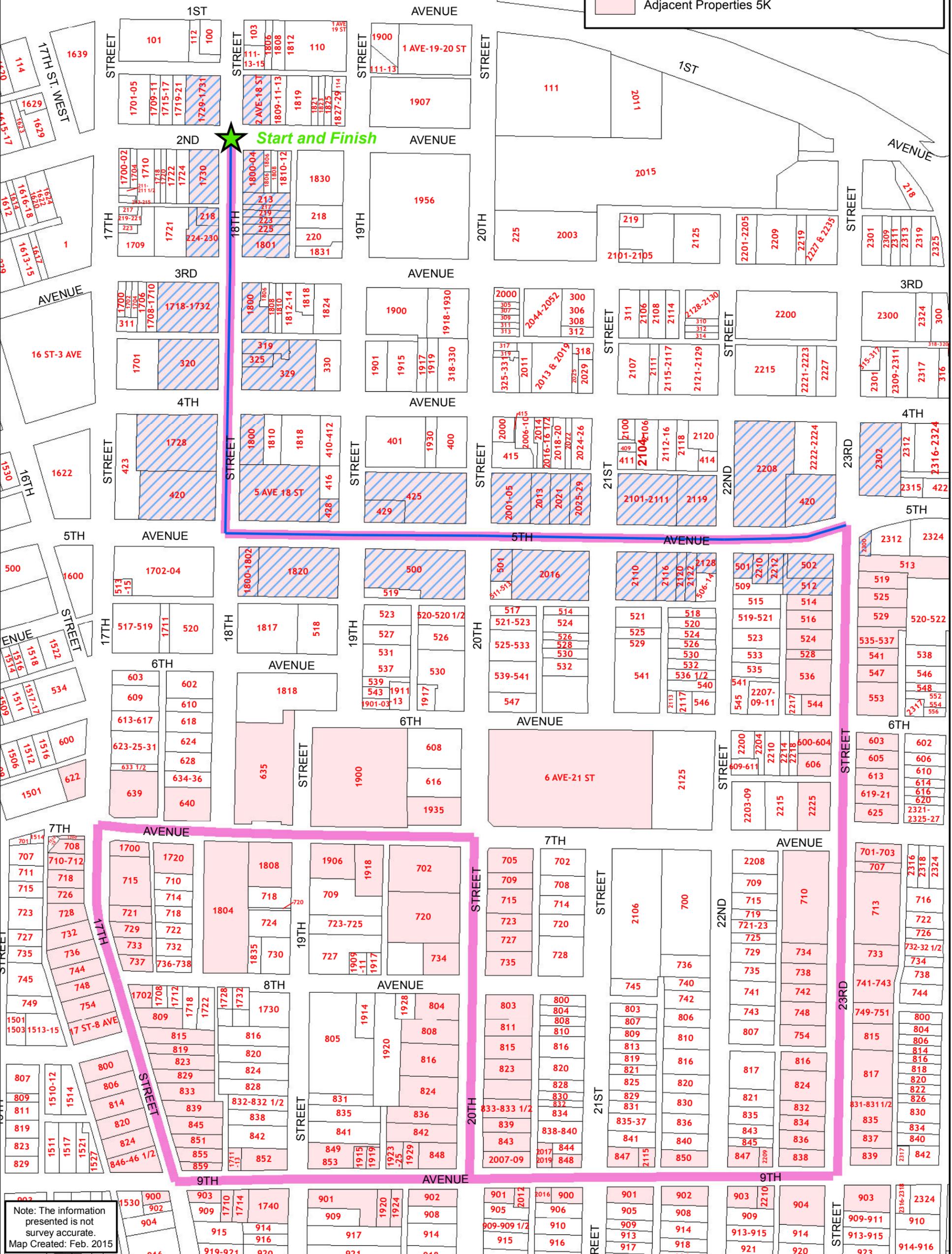
Gilda's Run

Please note: requests for changes that require Council approval should be received by the City Clerk at least two weeks prior to Council meeting. Council can only act on items that are on the printed agenda for that meeting. Items that require decisions can no longer be added to the agenda once it is printed and distributed.
- Sound Amplification must be specifically requested.
- Alcohol sales require a state and local license, and alcohol sales must be in a properly demarcated area which prevents entry by minors in accordance with Chapter 3 of the Code of Ordinances of the City of Rock Island. You must also detail security plans establishing your system for checking identification and verifying age.
- Alcoholic beverages cannot be sold/served in glass or cans on the plaza. All alcoholic beverages will be served in plastic cups.
- If you are planning an entertainment venue or activity on the Plaza, you will need to hire an appropriate number of Police Officers as determined by the Police Department. Arrangements must be made at least one month prior to your scheduled event. You may contact the Agent assigned to the Office of Professional Standards at (309) 732-2402.

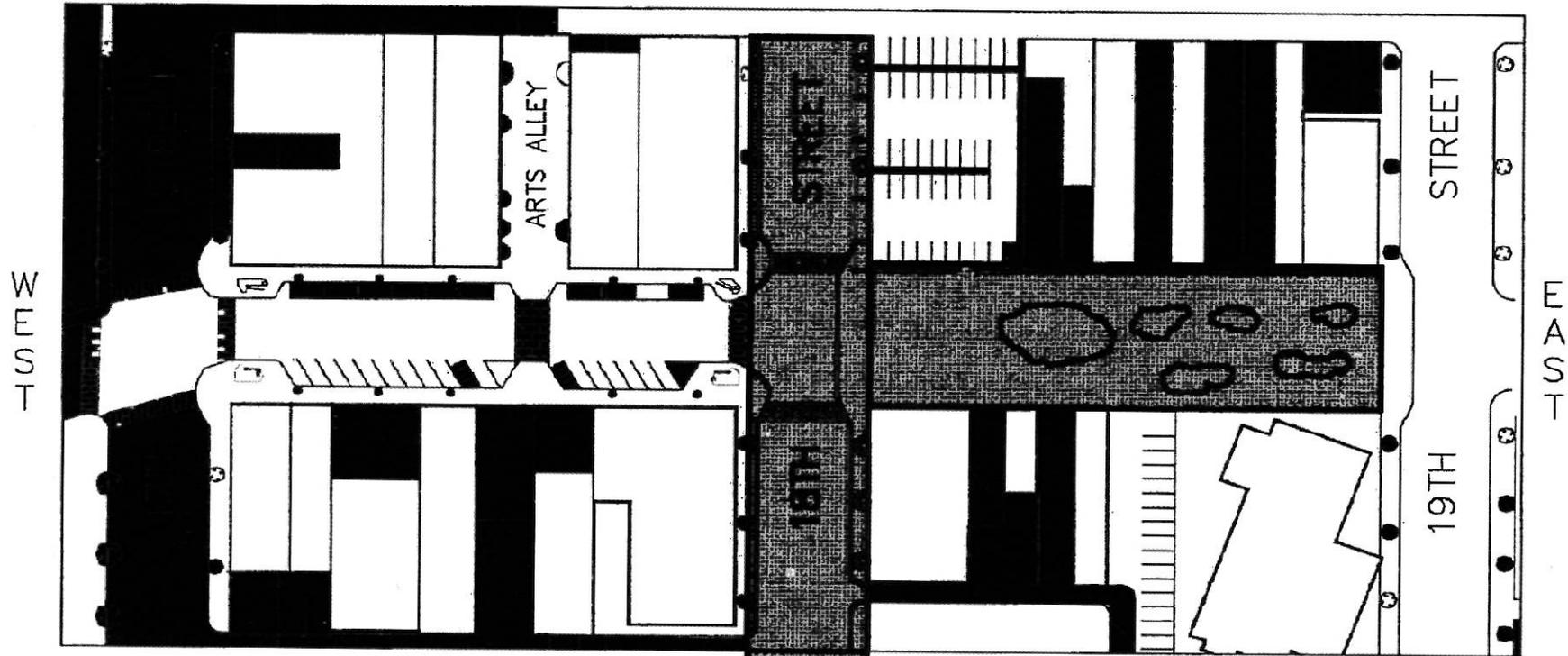

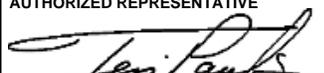
