Subject: Alleman High School 5K & 1-Mile Race Event
Date: April 6, 2015



Attached is an Activity application, letter and two (2) maps from Daniel DeJaegher on behalf of Alleman Catholic High School. They are requesting to hold a 5K road race and a 1-Mile road race on Saturday, June 27, 2015 from 7:30 am to 9:30 am. Both races will begin and end at Alleman High School.

The Alleman Pioneer 5K Race will begin on 41st Street by the Alleman parking lot at 8:00 am, and turn right onto 14th Avenue and proceed down 14th Avenue across 25th Street. The course will turn north on 24^½ Street and circle around the field and playground at Hauberg Park by turning west on 13th Avenue and then left onto 24th Street. The race will proceed east to 17th Avenue then north onto 24th Street, and then east to 14th Avenue to return back to the school.

The 1 mile Fun Run will be held after the 5K race. The 1-Mile race will start and end at the same locations as the 5K race, but will turn short of half a mile just before 34th Street on 14th Avenue.

They will be contacting the Police Department for traffic control. The certificate of insurance is attached.

It is recommended that Council approve the event for Alleman High School.

Prior to Council consideration, sponsor shall notify and obtain written approval or disapproval from the residents and/or businesses and submit a copy of same to the City Clerk. Any resident and/or business who objects to said event shall have the opportunity to be heard at the City Council meeting during which time the event is to be considered.

Note: The sponsor notification form for any new event/route is available in the City Clerk's office.

A copy of your application will be submitted to the Police Department for assistance with any needed traffic control. All required insurance papers must be attached to this application. Permit cannot be issued without proof of insurance.


RE: Pioneer Trailblazer 5K Race

Alleman Catholic High School is requesting to hold a 5K and 1 mile race on June 27, 2015. In particular, we are requesting permission and police protection. The race will be based at Alleman. We plan to set up cones at 7am on the course and request rolling course protection between approximately 7:30AM to 9:30AM.


The 5K course will begin on 41st Street by the Alleman parking lot at approximately 8 AM, turn right onto 14th Avenue, and then proceed down 14th Ave across 25th Street. The course will turn right (North) on 24 ½ Street and circle around the field and playground at Hauberg park by turning left (West on 13th Ave) and then left onto 24th Street. The race will proceed East by turning left again on 17th Avenue and then North on 24th Street. The course will turn right (East) to return back to the school on 14th Avenue. The course will finish by turning left on 41st Street and cross the Alleman parking lot for the finish into the Courtyard of Alleman. We plan to hold a single water stop for both directions of the race on 14th Avenue about where 26th Street would cross. The 1 mile fun run will follow shortly after the 5k which begins at 8:00 am. The 1 mile will start and end at the same locations as the 5K, but will turn short of half a mile -just before 34th Street on 14th Avenue. Maps for both races are attached. A post-race party and awards ceremony will be held at Alleman for participants and volunteers.

The 2014 race, the first year of the event, had over 225 participants. This year, we are planning for approximately 300 participants because of the wonderful support of the Rock Island and Alleman communities. We will be doing advanced registration for this event, so if our numbers begin to vary significantly from this estimate we will notify any departments that need to be made aware of the increased number of participants.


