Attached is an application from the St. Patrick Society and a Resolution to temporarily close off the east side of 15th Street (Route 67) from 2nd Avenue to the Centennial Bridge for the annual St. Patrick's Day Parade to be held on Saturday, March 12, 2016 between 11:00 am and 1:00 pm. It is noted that prior to the parade, a Riverbend Food Bank Drive will commence at 11:00 am with the parade actually starting at 11:30 am.

The staging area for the parade is on 5th Avenue (the parking lane and two (2) traffic lanes) from 16th Street to 23rd Street and 23rd Street between 4th and 5th Avenues. The parade will begin at the intersection of 23rd Street and 4th Avenue.

A certificate of insurance will be submitted prior to the event. The Police Department will create the Operations Order for the event.

RECOMMENDATION:

It is recommended that Council approve the event for the St. Patrick Society and adopt the Resolution.

Notification to Residents: In the case of applications for new events and/or new routes, the sponsor of said new event shall notify the residents and/or businesses located along said race route, parade route, or other, for that specific activity, in writing, at least three (3) weeks prior to City Council consideration. Prior to Council consideration, sponsor shall notify and obtain written approval or disapproval from the residents and/or businesses and submit a copy of same to the City Clerk. Any resident and/or business who objects to said event shall have the opportunity to be heard at the City Council meeting during which time the event is to be considered.

Note: The sponsor notification form for any new event/route is available in the City Clerk's office.

A copy of your application will be submitted to the Police Department for assistance with any needed traffic control. All required insurance papers must be attached to this application. Permit cannot be issued without proof of insurance.



RESOLUTION NO. 20-2015

HIGHWAY RESOLUTION

WHEREAS, the ST. PATRICK SOCIETY is sponsoring a PARADE in the CITY of ROCK ISLAND which event constitutes a public purpose;

WHEREAS, this PARADE will require the temporary closure of the east side of 15th Street (ROUTE 67) a State Highway in the CITY of ROCK ISLAND, from 2nd Avenue to the Centennial Bridge.

WHEREAS, Section 4-408 of the Illinois Highway Code authorizes the Department of Transportation to issue permits to local authorities to temporarily close portions of State Highways for such public purposes;

NOW THEREFORE, BE IT RESOLVED by the CITY COUNCIL of the CITY of ROCK ISLAND that permission to close off the east side of 15th Street (ROUTE 67) a State Highway in the CITY of ROCK ISLAND, from 2nd Avenue to the Centennial Bridge as above designated, be requested of the Department of Transportation.

BE IT FURTHER RESOLVED that this closure shall occur during the approximate time period between the hours of 11:00 a.m. and 1:00 p.m. on SATURDAY, MARCH 12, 2016.

BE IT FURTHER RESOLVED that this closure is for the public purpose of A PARADE.

BE IT FURTHER RESOLVED that traffic from that closed portion of highway shall be detoured over routes with an all-weather surface that can accept the anticipated traffic, which will be maintained to the satisfaction of the Department and which is conspicuously marked for the benefit of traffic diverted from the State Highway. (The parking of vehicles shall be prohibited on the detour routes to allow an uninterrupted flow of two-way traffic.) * The detour route shall be as follows: No Detour Needed.

*To be used when appropriate

BE IT FURTHER RESOLVED that the ST. PATRICK SOCIETY assumes full responsibility for

the direction, protection, and regulation of the traffic during the time the detour is in effect.

BE IT FURTHER RESOLVED that police officers or authorized flaggers shall, at the expense of the ST. PATRICK SOCIETY, be positioned at each end of the closed section and at other points (such as intersections) as may be necessary to assist in directing traffic through the detour.

BE IT FURTHER RESOLVED, that police officers, flaggers, and officials shall permit emergency vehicles in emergency situations to pass through the closed area as swiftly as is safe for all concerned.

BE IT FURTHER RESOLVED, that all debris shall be removed by the ST. PATRICK SOCIETY prior to re-opening the State Highway.

BE IT FURTHER RESOLVED, that such signs, flags, barricades, etc., shall be used by the ST. PATRICK SOCIETY as may be approved by the Illinois Department of Transportation. These items shall be provided by the ST. PATRICK SOCIETY.

BE IT FURTHER RESOLVED, that the closure and detour shall be marked according to the Illinois Manual on Uniform Traffic Control Devices.

BE IT FURTHER RESOLVED that an occasional break shall be made in the procession so that traffic may pass through. In any event, adequate provisions will be made for traffic on intersecting highways pursuant to conditions noted above. (Note: this paragraph is applicable when the Resolution pertains to a parade or when no detour is required.)

BE IT FURTHER RESOLVED, that the ST. PATRICK SOCIETY hereby agrees to assume all liabilities and pay all claims for any damage which shall be occasioned by the closing described above.

BE IT FURTHER RESOLVED, that the ST. PATRICK SOCIETY shall provide a comprehensive general liability insurance policy or an additional insured endorsement in the amount of \$100,000 per person and \$500,000 aggregate which has the Illinois Department of Transportation and its officials, employees, and agents as insured and which protects them from all claims arising from the requested road closing.

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Department of

Transportation to serve as a formal request for the permission sought in this Resolution and to operate as part of the conditions of said permission.
