Subject: Outdoor Entertainment & Alcohol Requests - Junior's Tap

Attached is a letter from Junior's Tap (Dee's Place) requesting permission for outdoor entertainment on Saturday, October 24, 2015 from 1:00 pm to 11:00 pm for a Birthday Party at 2536 5th Avenue.

Also attached is a letter requesting permission for alcohol to be taken outside to the demarcated area during the event.

A portion of the parking lot will be used for this event, which will be roped off. ID's will be checked and wristbands will be utilized for age verification. It is noted that all alcohol will be purchased from inside the establishment. However, Junior's Tap would like for their patrons to be allowed to carry alcoholic beverages from inside the establishment to the demarcated area outside. Junior's Tap will provide security personnel to ensure that minors do not enter the demarcated area.

It is noted that the amplified sound (music) portion of the event will include Karaoke from 5:00 pm to 10:00 pm. Junior's Tap has stated that the neighbors that may be affected by the sound amplification will be notified.

The certificate of insurance is on file.

RECOMMENDATION:

It is recommended that Council approve the request for outdoor entertainment and outdoor alcohol for Junior's Tap, subject to complying with all liquor license regulations and subject to being closed down early if noise complaints are received.
