Also attached is a letter requesting permission for Gunchies R.I. to sell alcohol outside during their event in the fenced in parking lot.

It is noted that ID's will be checked and wristbands will be utilized for age verification for patrons wishing to purchase alcohol in the fenced in area. In addition, the entertainment (music) will be provided by a DJ, and/or Band.

It is recommended that Council approve the requests for outdoor entertainment and alcohol for Gunchies R.I., subject to complying with all liquor license regulations and subject to being closed down early if noise complaints are received.

This would take place in the parking lot of Gunchies located at 2107 4th Ave Rock Island. The sales of alcohol would occur between the hours of 8am and midnight on the 12th of March.

The area will be defined and secured by barriers and fencing, with limited entrance and exit, and those entrances and exits monitored by personnel to ID patrons and wrist band customers with the proper age requirements to consume alcohol. No glass containers of any kind will be used outdoors during this event. There will be an outdoors temporary bar with ice coolers for beer sales, a register, etc.
