Attached is a letter from Ellen Clow, Group Sales Director for Circa '21 Dinner Playhouse requesting that approximately 11 parking spaces be blocked off on the north side of 3<sup>rd</sup> Avenue directly across the street from the theatre and two parking spaces on the west side of 19<sup>th</sup> Street around the corner north of 3<sup>rd</sup> Avenue on Saturday, August 13<sup>th</sup> from 2:00 pm to 6:00 pm.

Ms. Clow stated that the Mid Illinois Corvette Club will be attending a performance at Circa '21 on the evening of August 13<sup>th</sup> and they would like to have these vintage corvettes lined up on display.

In addition, Ms. Clow has stated that the parking spaces would not be blocked off until the QC Coffee and Pancake House has closed for the day, which is at 2:00 pm.

The purpose of the request is to draw attention to Circa '21 and Downtown Rock Island.

**RECOMMENDATION:**

It is recommended that Council approve the request to block off 13 parking spaces for Circa '21 Dinner Playhouse and authorize the Public Works staff to provide the barricades.
