To Whom It May Concern:

The Apostolic Sanctuary of Rock Island would like to host their 6<sup>th</sup> Annual "Revival – Rock Island" Event this coming September 9-11 at the 3800 block of 11<sup>th</sup> Street in Watch Tower Plaza parking lot.

The event would begin with an "open-air" worship service on Friday evening September 9<sup>th</sup> at 7pm under a 40'x60' tent and would last until 9pm. The sound system would be used from 6pm-9pm.

Saturday holds the bulk of the weekend long event. At 10am there is a FREE Clothing Give-Away that is open to the community under the 40'x60' tent. In years past we have witnessed 300+ people come through and benefit from it.

Coinciding with the Clothing Give-Away there is a "Community Cook-Out" starting at 11am. People that stop by will be given a FREE Lunch, a safe place to eat with their family & friends, activities & games for children (including bounce houses, face painting, a giant inflatable slide, etc.) and Christian/Gospel music playing through speakers in the background. This would end by 2pm.

Saturday evening will hold another "open-air" worship service at 7pm under the tent. The sound amplification system would be used beginning at 5:30pm for music practice and would be shut-off by 9pm.

Sunday's Worship Service would conclude the weekend long event. This service would begin at 2pm and would end around 4pm. The sound system would potentially be used from 12:30pm – 5pm (at the latest).
