Attached is a letter from the Reverend Willie E. Jones of the People's Missionary Baptist Church requesting that parking be permitted at the curbside along the east and west sides of 23<sup>rd</sup> Street between 5<sup>th</sup> and 6<sup>th</sup> Avenues on Monday, September 26, Tuesday, September 27 and Thursday, September 29, 2011 from 5:30 pm to 9:00 pm for their annual Fall Revival.

On Monday, November 19, 2007 a Special Ordinance was amended and approved by Council allowing the People's Missionary Baptist Church congregation to park on both sides of 23<sup>rd</sup> Street between 5<sup>th</sup> and 6<sup>th</sup> Avenues on Sundays and Wednesdays only, while the parking area on both sides of 23<sup>rd</sup> Street between 5<sup>th</sup> and 6<sup>th</sup> Avenues be restricted to Type B residential permit parking area on Mondays, Tuesdays, Thursdays, Fridays and Saturdays. The Special Ordinance also eliminated Type B residential permit parking area in front of 553 23<sup>rd</sup> Street and in front of 2300 5<sup>th</sup> Avenue. Attached is a copy of the Special Ordinance.

**RECOMMENDATION:**

It is recommended that Council approve the request from the People's Missionary Baptist Church and allow parking at the curbside along the east and west sides of 23<sup>rd</sup> Street between 5<sup>th</sup> and 6<sup>th</sup> Avenues from 5:30 p.m. to 9:00 p.m. on Monday, September 26, Tuesday, September 27 and Thursday, September 29, 2011.

ORDINANCE NO. 084-2007

A SPECIAL ORDINANCE AMENDING SPECIAL ORDINANCE  
NO. 075-2007 IN THE CITY OF ROCK ISLAND, ILLINOIS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROCK ISLAND, ILLINOIS:

Section One. Special ordinance number 075-2007 is hereby amended by deleting the following language:

"Section One: That the parking area on both sides of 23<sup>rd</sup> Street between 5<sup>th</sup> and 6<sup>th</sup> Avenue in the City of Rock Island, Illinois be and is hereby determined to be a Type B residential permit parking only area pursuant to the provisions of Section 9-97 through 9-100 of Division 5, Chapter 9 of the Code of Ordinances of the City of Rock Island, Illinois."


and by inserting in lieu thereof the following:

"Section One. That the parking area on both sides of 23<sup>rd</sup> Street between 5<sup>th</sup> and 6<sup>th</sup> Avenues in the City of Rock Island, Illinois be and is hereby determined to be a Type B residential permit parking only area, pursuant to the provisions of Section 9-97 through 9-100 of Division 5, Chapter 9 of the Code of Ordinances of the City of Rock Island, Illinois, and subject to the following stipulations:

- a. Type B residential permit parking area on both sides of 23<sup>rd</sup> Street between 5<sup>th</sup> and 6<sup>th</sup> Avenues is restricted to Monday, Tuesday, Thursday, Friday and Saturday, and not in effect on Sunday or Wednesday; and
- b. Type B residential permit parking area is eliminated in front of 553 23<sup>rd</sup> Street, and in front of 2300 5<sup>th</sup> Avenue, Rock Island, Illinois."

Section Two. All ordinances and parts of ordinances in conflict herewith are hereby repealed insofar as they do so conflict.

Section Three. This ordinance shall be in full force and effect from and after its passage and approval, as required by law.
