Attached is an application from the St. Patrick Society and a Resolution to temporarily close off the east side of 15<sup>th</sup> Street (Route 67) from 2<sup>nd</sup> Avenue to the Centennial Bridge for the annual St. Patrick's Day Parade to be held on Saturday, March 17, 2012 between 11:30 am and 1:30 pm.

The staging area for the parade is on 5<sup>th</sup> Avenue (the parking lane and two (2) traffic lanes) from 17<sup>th</sup> Street to 23<sup>rd</sup> Street and 23<sup>rd</sup> Street between 4<sup>th</sup> and 5<sup>th</sup> Avenues. The parade will begin at the intersection of 23<sup>rd</sup> Street and 4<sup>th</sup> Avenue.

A certificate of insurance will be submitted prior to the event. The Police Department will create an Operations Order before to the event.

**RECOMMENDATION:**

It is recommended that Council approve the event and adopt the Resolution.



## RESOLUTION NO. 16-2011

### HIGHWAY RESOLUTION

WHEREAS, the ST. PATRICK SOCIETY is sponsoring a PARADE in the CITY of ROCK ISLAND which event constitutes a public purpose;

WHEREAS, this PARADE will require the temporary closure of the east side of 15<sup>th</sup> Street (ROUTE 67) a State Highway in the CITY of ROCK ISLAND, from 2<sup>nd</sup> Avenue to the Centennial Bridge.

WHEREAS, Section 4-408 of the Illinois Highway Code authorizes the Department of Transportation to issue permits to local authorities to temporarily close portions of State Highways for such public purposes;

NOW THEREFORE, BE IT RESOLVED by the CITY COUNCIL of the CITY of ROCK ISLAND that permission to close off the east side of 15<sup>th</sup> Street (ROUTE 67) a State Highway in the CITY of ROCK ISLAND, from 2<sup>nd</sup> Avenue to the Centennial Bridge as above designated, be requested of the Department of Transportation.

BE IT FURTHER RESOLVED that this closure shall occur during the approximate time period between the hours of 11:30 a.m. and 1:30 p.m. on SATURDAY, MARCH 17, 2012.

BE IT FURTHER RESOLVED that this closure is for the public purpose of A PARADE.

BE IT FURTHER RESOLVED that traffic from that closed portion of highway shall be detoured over routes with an all-weather surface that can accept the anticipated traffic, which will be maintained to the satisfaction of the Department and which is conspicuously marked for the benefit of traffic diverted from the State Highway. (The parking of vehicles shall be prohibited on the detour routes to allow an uninterrupted flow of two-way traffic.) \* The detour route shall be as follows: No Detour Needed.

\*To be used when appropriate

BE IT FURTHER RESOLVED that the ST. PATRICK SOCIETY assumes full responsibility for the direction, protection, and regulation of the traffic during the time the detour is in effect.

BE IT FURTHER RESOLVED that police officers or authorized flaggers shall, at the expense of the ST. PATRICK SOCIETY, be positioned at each end of the closed section and at other points (such as intersections) as may be necessary to assist in directing traffic through the detour.

BE IT FURTHER RESOLVED, that police officers, flaggers, and officials shall permit emergency vehicles in emergency situations to pass through the closed area as swiftly as is safe for all concerned.

BE IT FURTHER RESOLVED, that all debris shall be removed by the ST. PATRICK SOCIETY prior to re-opening the State Highway.

BE IT FURTHER RESOLVED, that such signs, flags, barricades, etc., shall be used by the ST. PATRICK SOCIETY as may be approved by the Illinois Department of Transportation. These items shall be provided by the ST. PATRICK SOCIETY.

BE IT FURTHER RESOLVED, that the closure and detour shall be marked according to the Illinois Manual on Uniform Traffic Control Devices.

BE IT FURTHER RESOLVED that an occasional break shall be made in the procession so that traffic may pass through. In any event, adequate provisions will be made for traffic on intersecting highways pursuant to conditions noted above. (Note: this paragraph is applicable when the Resolution pertains to a parade or when no detour is required.)

BE IT FURTHER RESOLVED, that the ST. PATRICK SOCIETY hereby agrees to assume all liabilities and pay all claims for any damage which shall be occasioned by the closing described above.

BE IT FURTHER RESOLVED, that the ST. PATRICK SOCIETY shall provide a comprehensive general liability insurance policy or an additional insured endorsement in the amount of \$100,000 per person and \$500,000 aggregate which has the Illinois Department of Transportation and its officials, employees, and agents as insured and which protects them from all claims arising from the requested road closing.

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the Department of Transportation to serve as a formal request for the permission sought in this Resolution and to operate as part of the conditions of said permission.
