The event will include outdoor tents, a beer wagon and mixed drinks being served outdoors. All food will be prepared inside the establishment. The premises will be fenced. Roosters Sports Bar and Grill will provide security personnel to ensure that minors do not enter the fenced in area. I.D.'s will be checked for age verification and wristbands will be utilized.

There will be no live outdoor entertainment. The certificate of insurance is forthcoming.

The purpose of the event is to contribute to the St. Patrick's Day Parade festivities and to bring awareness to the community of this newly opened business.

We are writing you this letter in regards to a request for an outdoor event permit for Roosters Sports Bar & Grill, located at 2130 3rd Avenue, Rock Island. We would like to request to be permitted to have an outdoor event on March 17, 2012 for the purpose of serving alcohol outdoors during the events of St. Patrick's Day, both during the parade and after. We feel like this would be a great way to capitalize on the crowds that are gathering Downtown Rock Island, which would help serve the interests of our business, as well as the City.

This event would include outdoor tents, an outdoor beer wagon and troughs, and mixed drinks being served outdoors. We will be opening Roosters Sports Bar & Grill at 8:00 AM on March 17, 2012.
