The parking lot will be used for this event, which will be fenced and the beer garden will be roped-off. Kavanaugh's Hilltop Tavern is providing security people. ID's will be checked and wristbands will be utilized for age verification.

It is noted that amplified sound (music) will be provided by live bands. Kavanaugh's Hilltop Tavern has stated that the neighbors that may be affected by the sound amplification will be notified.

The purpose of this event is to help defray the cost of medical expenses for Sherri Gleason Shea, to bring her children home for the summer and to help with expenses for a family vacation.

In the past, the Hilltop Tavern has held similar events outside at this location without any problems. The certificate of insurance is forthcoming.

It is recommended that Council approve the outside event for Kavanaugh's Hilltop Tavern, subject to complying with all liquor license regulations and subject to being closed down early if noise complaints are received.
