Attached is a letter from Kavanaugh's Hilltop Tavern and the Ride with Kelly Foundation, Inc. requesting permission to hold the second annual outdoor benefit - Ride with Kelly Foundation Charity Motorcycle Ride on Saturday, June 9, 2012 from 2:00 pm to 8:00 pm at Kavanaugh's Hilltop Tavern located at 1228 30th Street.

The parking lot will be used for this event, which will be fenced and the beer garden will be roped-off. Kavanaugh's Hilltop Tavern is providing security people and off-duty Police Officers. ID's will be checked and wristbands will be utilized for age verification.

It is noted that amplified sound (music) will be provided by a live band. Kavanaugh's Hilltop Tavern has stated that the neighbors that may be affected by the sound amplification will be notified.

The purpose of this family oriented event is to raise money to provide emotional and financial support for children in need that are grieving the loss of a parent or sibling in the Quad City area.

In the past, the Hilltop Tavern has held similar events outside at this location without any problems. This event is open to the public and the certificate of insurance is forthcoming.

RECOMMENDATION:

It is recommended that Council approve the outside event for Kavanaugh's Hilltop Tavern, subject to complying with all liquor license regulations and subject to being closed down early if noise complaints are received.

The past year's event went well and we had no problems.


